On the listed date and time, the undersigned officer responded to assist officers with an assignment at the listed location. Upon arrival on the scene, a preliminary investigation revealed that RP-1 reports while MPD officers were assisting the Office of the Deputy Mayor for Health and Human Services with a Homeless Outreach Clean-Up Project, S-1 observed SPO Sgt Hughes of the Metropolitan Police Department, who was in full uniform displaying the MPD Badge and Metropolitan Police Department patches on the outer part of her garments, making it apparent that she was Law enforcement acting in the performance of her official duties and responsibilities, decided to impede and harass her by jumping in front of her as to prevent her from inspecting a tint at the listed location. S-1 further without justifiable and excusable cause assaulted SPO Sgt Hughes by smacking her left hand causing a cut to her thumb that began to bleed as she attempted to open the tint.
